## **Patient Centered Medicine 3 Course Objectives**

### 1. Medical Knowledge

Discuss how cultural beliefs and spiritual practices influence health outcomes (SSOM Competency 1.5)

Identify factors which may lead to health disparities including insurance and immigration status.(1.5)

Identify critical issues and principles of management in the care of seriously ill and dying patients (1.4)

#### 2. Patient Care

Actively participate in sessions that introduce students to the foundational skills necessary to begin clinical clerkships (2.4, 2.5)
